From the desk of Village President Greg Hribal

As many of you learned this past month, an iconic Westchester staple of 43 years is no more. It is with great sadness that we announce Paul's Pizza and Hotdogs closed its doors for the last time on Saturday, May 17. Paul originally opened at 31st and Downing in April 1982, later expanding the business to the shopping center at 31st and Wolf in the early 2000s.

Paul began his career in public service in 1998 when he became a village trustee. He went on to serve two terms as village president, stepping down in 2021. His involvement and commitment to the community extended beyond public office—he was a consistent supporter of the village, the parks, and the schools, and sponsored hundreds of local sports teams, providing food donations and financial support throughout the past 40 years. Thank you, Paul, for supporting the community for over four decades. Your dedication to public service and your role as a local business owner who always put Westchester first are deeply appreciated.

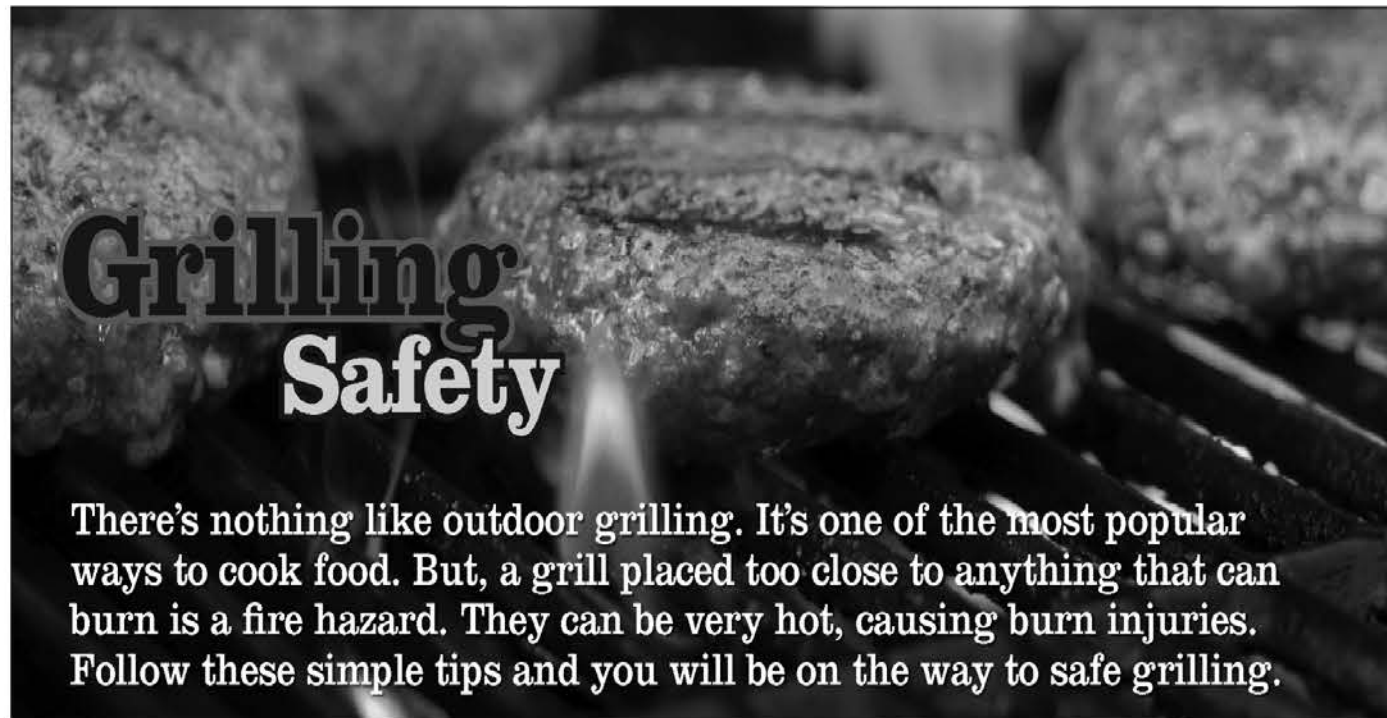

SAFETY TIPS

- » Propane and charcoal BBQ grills should only be used outdoors.
- » The grill should be placed well away from the home, deck railings and out from under eaves and overhanging branches.
- » Keep children and pets at least three feet away from the grill area.
- » Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- » Never leave your grill unattended.
- » Always make sure your gas grill lid is open before lighting it.

CHARCOAL GRILLS

- » There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.
- » If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
- » Keep charcoal fluid out of the reach of children and away from heat sources.
- » There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
- » When you are finished grilling, let the coals completely cool before disposing in a metal container.

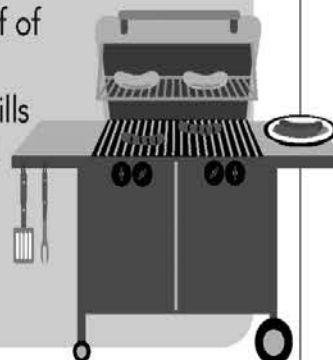
PROPANE Grills

Check the gas tank hose for leaks before using it for the first time each year. Apply a light soap and water solution to the hose. A propane leak will release bubbles. If your grill has a gas leak, by smell or the soapy bubble test, and there is no flame, turn off both the gas tank and the grill. If the leak stops, get the grill serviced by a professional before using it again. If the leak does not stop, call the fire department. **If you smell gas while cooking, immediately get away from the grill and call the fire department.** Do not move the grill.

If the flame **goes out**, turn the grill and gas off and wait at least **5 minutes** before re-lighting it.

FACTS

- ❗ July is the peak month for grill fires.
- ❗ Roughly half of the injuries involving grills are thermal burns.



Fire Safety Tips

It looks like the nice weather is finally here for Westchester!

As we start to enjoy our backyards, parks, and forest preserve with family and friends, please keep some outdoor fire and grilling safety tips in mind. Please keep your grills away from combustibles like your home and garage walls as well as patio furniture.

Please follow Westchester ordinances and keep fire pits at least 15 feet away from structures when using and keep a hose or water bucket nearby.

You can check the village website for current village rules for outdoor fires.

307.4.3 Portable outdoor fireplaces.

Portable outdoor fireplaces (e.g. fire pits) shall be used in accordance with the manufacturer's instructions and shall not be operated within 15 feet of a structure or combustible material.

** NFPA data show that between 2019 and 2023, gas grills were involved in an average of 9,287 home fires per year, including 4,682 structure fires and 4,605 outdoor fires. In roughly one-fifth (20%) of these fires, the grill had not been cleaned. In addition, an annual average of 21,682 patients went to emergency rooms because of grill-related injuries between 2020 and 2024, according to data from the U.S. Consumer Product Safety Commission.*

Enjoy Fourth of July FUN Without the FINES!

It's never too early to talk about one of the most celebrated holidays in this great land we call the United States of America. This country will be 249 years old this Fourth of July—and of course, it lands on a Friday!

While that's great for celebrations, it's also one of the most challenging nights of the year for police officers across the country.

Last year, I worked the Fourth of July alongside my officers.

We issued 20 citations for illegal fireworks, each carrying a **\$750 fine**. Some individuals even received second violations.

While we want everyone to enjoy the

holiday with friends and family, it must not come at the expense of someone's safety, property—or peace of mind.

Chasing down fireworks across the sky, in every direction, trying to pinpoint where they're coming from—it's not fun.

And it gets harder when people who've been drinking try to argue why they should be allowed to break the law.

Our job is to protect all residents, including your homes and pets, and we take that responsibility seriously. Some of the most common responses we hear from those violating the law include:

- "I didn't know they were illegal." **Yes, fireworks are illegal throughout the entire State of Illinois.**

- "*Why are you writing me up and not the guy two blocks over?*" **There's no order to enforcement—we act when we locate a violation and then move on to the next call.**

- "*We're just having fun.*" **Yes, but sometimes that fun comes with risk, danger, and real harm to others. So once again, I'm asking residents: please leave fireworks to the certified professionals.**

We have over six thousand homes in West-

chester, and while our team works hard to keep everyone safe, we need your help.

Don't shoot off fireworks. Instead, enjoy a **safe, fun, and phenomenal Fourth of July weekend** by joining us for the parade and celebrating responsibly.

Remember, fireworks are totally illegal in the Village of Westchester—and a violation carries a \$750 fine.

Thank you for doing your part to keep our community safe.

SLOW MOW IS THE WAY TO GO

Q: Why didn’t the Village do No Mow Til Mothers Day this year? How do we help the pollinators?

A: You might remember that last year, GROW and the Village tried “No Mow ‘Til Mother’s Day,” inspired by the UK’s “No Mow May” movement. But here in the Chicago area, spring warmed up fast — and so did our lawns. Grass shot up, went to seed early, and by summer, many yards became tough to manage.

It turns out, “No Mow May” works better in cooler, wetter climates like the UK. Here in Westchester, we need a more flexible approach to support pollinators and keep our yards manageable.

This summer, we’re encouraging Slow Mow Summer.

The basic idea of “No Mow...” campaigns is to hold off on mowing to let the flowers bloom. For most of us, this means giving the plants and weeds in our lawns (like dandelions, violets, and clover) a chance to flower and become a pollinator food source, then mow before they go to seed.

“Slow Mow” means that you let your lawn grow to five inches before cutting it down to 3.5 inches. That’s what we do for our lawn and we receive lots of compliments on how healthy it looks (especially while dotted with dandelions, clover, and violets!)

The best part about leaving the grass longer

(as well as holding off on the spring clean-up) is that it creates the conditions for a yard full of fireflies and butterflies!

Slow Mow Summer helps to:

• **Prevent weeds:** Letting your grass grow a bit longer naturally shades out weed germination and growth, helping you spend less time pulling them — and reducing the need for chemical weed killers.

• **Promote Healthier Grass:** Taller grass fosters deeper roots and more resilient lawns, saving you time and money in the long run.

• **Enhance Wildlife Habitat:** Longer grass provides shelter and food for bees, butterflies, and fireflies.

• **Reduce Pollution:** Fewer mowing sessions mean less fuel use and emissions.

This summer, take it slow and be flexible: Adjust to a slower mowing schedule, whether you cut the law yourself or have a service involved. Watch how nature responds and tailor your approach to what works best for your yard.

Even if you like a tidier lawn, mowing less

frequently can still save you time and money while benefiting your home environment. Healthier grass, less fuel use, fewer emissions, and more support for biodiversity — all with a neater appearance!

If Slow Mow isn’t for you - other tips to improve your environment:

If you can’t stand the thought of changing your lawncare routine, there are other ways you can contribute:

• **Chemical-Free Zones:** Avoid pesticides and herbicides that can poison the soil and the insects that call it home — fireflies included.

• **Native Landscaping:** Shrink your lawn and add a large native plant border - there are many beautiful plants, including Purple Coneflower, our Village’s official flower.

• **Spread some other ground covers:** Incorporate native lawn alternatives like clover and violets to provide a continuous food source for local pollinators.

Recipe of the Month

Lentil Tacos with Roasted Cauliflower
makes 4 servings

Ingredients

- 1 large head of cauliflower, separated into florets
- 1 medium onion, 3/4 cup finely chopped
- 2 large cloves of garlic, finely chopped
- 3 tablespoons of tomato paste
- 1 teaspoon ground cumin
- 1 teaspoon chili powder
- ¾ cup brown lentils
- 2 cups of vegetable broth or water
- 8 corn or flour tortillas
- 2 medium avocados
- 1 tablespoon fresh lemon
- 1 tablespoon cider vinegar
- Handful of fresh cilantro or parsley

Instructions

Roast Cauliflower:

- In a large bowl, toss cauliflower with 3 tablespoons of olive oil, salt and black pepper. Arrange evenly and in a single layer on parchment-lined baking sheet.
- Bake for 30 minutes at 425 deg F, flipping halfway until cauliflower has crispy golden edges.

Make Lentil filling:

- In a medium pot, add to 1 tablespoon of olive oil over medium heat, onions, garlic and salt sautéing for 5 minutes, until onions soften.
- Add tomato paste, cumin, and chili powder to pot, stirring over medium heat for 1-2 more minutes.
- Add lentils and broth to pot, stirring until mixture comes to a gentle boil.
- Lower heat to simmer, uncovered, for about 30 minutes.
- Drain any liquids before making tacos.

Making Avocado Sauce:

- Combine avocados, lemon juice, vinegar, and salt.
- Then process in a food processor until smooth.
- To assemble tacos, place a small portion of lentil mixture on warmed tortilla. Add cauliflower and drizzle with avocado sauce. Top with chopped cilantro or parsley.

PUBLIC WORKS

Village branch collection for June will be the week of June 2nd – 6th

July’s collection will be the week of July 7th – 11th

August’s collection will be the week of August 4th – 8th

The Public Works Department will collect branches the first full working week of every month (April-November)

- All brush must be put out on the front parkway by 7:00 a.m. on your designated collection day. Branches can be up to 7 feet in length and stacked with the butt ends facing the street in the same direction. If not stacked properly, a “restack” notice will be left.
- Again, please put ALL brush out on your designated collection day and Public Works crews will determine what constitutes an open load, which will be picked up later in the week.

- An open load would include any brush that will not fit through the chipper such as logs, stumps, and large limbs. These must be cut for one man to lift. Dirt must be removed from any root balls for pickup.

- Public Works Crews will only pass through a designated pickup area once due to time, scheduling, and other workload responsibilities.

Landscapers & tree services are responsible for their own

debris disposal.

Please note the following schedule for branch pickup:

MONDAY: From Mannheim Rd west to Wolf Rd and from Canterbury St south to Windsor Dr-including both sides of Windsor Dr. Also Waterford, Waverly, Camelot and Concord.

TUESDAY: Roosevelt Rd south to Cermak Rd-from Gardner Rd west to Mannheim Rd.

WEDNESDAY: From Roosevelt Rd north to the expressway and from Gardner Rd west to Mannheim Rd. Also, Roosevelt Rd south to Canterbury St from Haase Ave west to Heidorn Ave.

THURSDAY: From Bellevue Ave west to Wolf Rd, Martindale Dr south to 31st Street.

Weekly yard waste collection by S.B.C. will begin on your first regular collection day in April.

- If your garbage, recycling, and/or yard waste was at the curb by 6am but was not collected by 6pm on your regular day, please call S.B.C. directly to report a missed collection.
- You may place two (2) large items that

will not fit in your receptacle (couch, chair, table, etc.) at the curb every week for collection. Please call S.B.C. directly to inform them of large items.

- S.B.C. will collect household hazardous waste and electronic waste (e-waste), at no additional charge, including household chemicals, automotive products, paint products, garden chemicals, universal materials, batteries, long fluorescent light-bulbs, and swimming pool chemicals. This separate collection must be pre-scheduled by calling 312-522-1115.

Street Parking Restrictions

From April 1 through November 30, parking restrictions are in effect to support **street maintenance activities**. Please check posted street signs carefully—it is unlawful to park or leave a vehicle parked during designated weekday hours on streets marked for maintenance.

These restrictions help ensure our streets stay clean and well-maintained. These restrictions are for one side of the street, once a week, 7am-3pm as designated by posted signage.

Westchester Tree Replacement Program

1. The Village has been planting trees on eligible parkways at no cost to the resident. This replacement program does not allow for residents to choose the species of tree planted, the location, the number of trees planted, nor are residents able to opt-out of having a tree planted in the Village parkway in front and/or side of their residence.

Please call Public Works if you would like to request a tree be planted, sooner rather than later, on any parkway.

2. If you would prefer to choose the species of the tree to be planted, this can be achieved through the 50/50 program. The resident may choose the tree(s) from a list provided by the Village, and shares half of the cost of the tree(s) and planting with the Village. To request the list of 50/50 trees, please call the Public Works Department at 708-345-0041.

Village Watering Restrictions

There are water use restrictions in effect every year, May 15th to September 15th, from 12pm to 6pm. This includes:

- (1) Outdoor Watering
- (2) Cleaning Outdoor Surfaces
- (3) Cleaning Buildings
- (4) Pool Filling
- (5) Sprinkling/ sprinklers

Outdoor water use during unrestricted hours (before noon, after 6pm) is allowed on even numbered days for residents with even numbered addresses, and on odd numbered days for residents with odd numbered addresses. If we have a dry summer, further restrictions may be necessary.

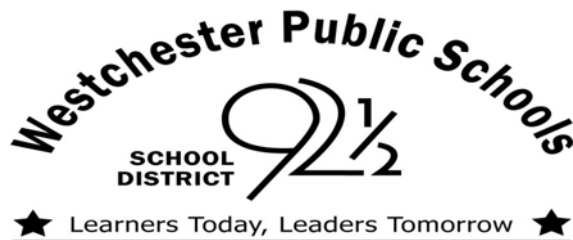

Introduction

The 1996 Safe Drinking Water Act passed by Congress mandates that every public water supply in the United States prepares and distributes an annual report on water quality. This annual report to water consumers in the Village of Westchester characterizes the quality of our drinking water. The format of this report is regulated by the United States Environmental Protection Agency (USEPA). USEPA requires certain mandatory language and data in this report. These informational items must be published every year in the Village’s Water Quality Report.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

All water can be contaminated by the following: Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban stormwater runoff, industrial, or domestic wastewater discharges, oil and gas productions, mining or farming; Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff and residential uses; Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff and septic systems; Radioactive contaminants, which may be naturally occurring or be the result of oil and gas production and mining activities; Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the USEPA Safe Drinking Water Hotline at 1-800-426-4791. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, people who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. USEPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the USEPA Safe Drinking Water Hotline 1-800-426-4791.

In order to ensure that tap water is safe to drink, the USEPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water, which must provide similar protection for public health.

Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of Westchester is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family’s risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. If you are concerned about lead in your water, you may wish to have your water tested, contact Public Works at (708) 345-0041. Information on lead in drinking water, testing methods, and steps that you can take to minimize exposure is available at www.epa.gov/safewater/lead.

The Village of Westchester constantly monitors and safeguards the water supply. Our dedicated team of experienced Water Operators is committed to providing its customers with safe drinking water, and we are pleased to share this water quality report with you for water tested from January 1, 2024 through December 31, 2024. Residents are welcome and encouraged to ask questions and/or provide comments at Village Board meetings. The Village Board meets on the first and third Tuesday of each month at 6 p.m. at Village Hall, 10300 W Roosevelt Rd, Westchester, IL 60154.

Water-related issues can also be reported by submitting a service request online at www.westchester-il.org or by phone at 708-345-0041. Our Water Department is happy to help resolve an issue.

As first responders, our Public Works team is also on duty 24/7/365 for water-related emergencies, such as water main breaks and/or damaged fire hydrants. For emergencies after hours, please call the police non-emergency phone number at 708-345-0060, and a crew will be dispatched.

All About Our Water System

Ever thought about where the water in your tap comes from each time you turn on the faucet? Well, the Village of Westchester Water Department, in partnership with the Broadview–Westchester Joint Water Agency (BWJWA) , is one of the groups making sure it gets to your home.

The water in your home originally comes from Lake Michigan. The City of Chicago Water Department takes the water out of Lake Michigan, treats it to make sure it is safe for drinking, and then pumps the water to all the homes and businesses in the City of Chicago, as well as allows the suburbs in Cook County to purchase water.

That is where the Broadview–Westchester Joint Water Agency takes over! BWJWA connects to the City of Chicago system and transmits the water to their 10th Avenue Pump Station. The water travels about 4.2 miles through a 24” pipe. The water then continues to flow in the 24” pipe, and once the water arrives at the 10th Avenue Pump Station, the water enters three underground storage reservoirs, each with a capacity of half-a-million gallons!

The 10th Avenue Pump Station has 6 pumps, 3 each for the Village of Westchester and the Village of Broadview. The Agency draws the water out of the reservoirs, treats the water with chlorine, and then pumps it to the Village of Broadview’s water system, and to the Village of Westchester’s Crestwood Avenue Pump Station where our Water Department performs thorough monitoring, treating, and testing before it is introduced into our water system.

The BWJWA is responsible for the operation and maintenance of the 24” water line, the 10th Avenue Pump Station building, and for monitoring the internal systems of their customers. The station and the portions of their customers’ systems are monitored and operated with a Supervisory Control And Data Acquisition (SCADA) system that uses radio frequencies to transmit information from each of the components of the Agency’s system as well as key components of their customers’ systems. This information is displayed on a large screen at the 10th Avenue Pump Station, and the personnel use this information to make adjustments in the operation of the system. The Agency personnel have iPads that allow them to view the information from the 10th Avenue station remotely and make adjustments.



NEXT TIME YOU TURN ON YOUR FAUCET, REMEMBER THE BROADVIEW–WESTCHESTER JOINT WATER AGENCY AND THE VILLAGE OF WESTCHESTER WATER DEPARTMENT ARE DILIGENTLY WORKING TO KEEP YOUR WATER SAFELY FLOWING.

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection only dilution. This is the reason for mandatory treatment for all surface water supplies in Illinois. Chicago’s offshore intakes are located at a distance that shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

Water Infrastructure Improvements

In 2024, the Village of Westchester took critical steps to address aging infrastructure, comply with state and federal mandates, and ensure the sustainability and safety of its water and sewer systems. With much of the Village's underground infrastructure dating back nearly a century, the need for proactive and strategic investment has never been greater. Nearly half of the Village's water mains, 27% of sanitary sewers, and 60% of storm sewers were installed in the 1920s and 1930s, leaving these systems in urgent need of modernization. Adding to the challenge is the federally mandated Lead Service Replacement Act, which requires the replacement of approximately 1,000 resident-side and 3,600 Village-side lead service lines by 2040. In response, the Village has embraced a proactive and responsible approach that prioritizes long-term financial planning, strategic infrastructure maintenance, and transparent governance to ensure a resilient future for the community.

2024 WATER & SEWER IMPROVEMENTS

A significant effort went into upgrading our aging water system, with 0.75 miles of 1920s-era water mains replaced and 126 lead service lines removed and updated to meet state mandates. Sanitary and storm sewer systems saw 6.5 miles of main lines cleaned and televised, while 1,263 feet of sanitary sewer were lined to ensure better performance and reliability.

PROFESSIONAL WATER & SEWER RATE STUDY

To address these priorities, the Village implemented initial utility rate adjustments in July 2024 to begin funding critical infrastructure improvements. However, recognizing the need for a more detailed analysis, the Village simultaneously proposed a professional Water and Sewer Rate Study to guide long-term infrastructure planning and ensure responsible financial stewardship. Initiated in 2024, the Village partnered with Baxter & Woodman to conduct the comprehensive Water and Sewer Rate Study. This initiative reflects the Village's commitment to thoughtful, data-driven decision-making.

ADDRESSING LEAD SERVICE LINE COMPLIANCE

Compliance with the Lead Service Replacement Act was a top priority for the Village in 2024, and significant progress was made toward meeting these mandates:

- **Lead Service Line Inventory:** The inventory was completed, submitted to the EPA, and made publicly available on the Village website in July 2024. This transparent approach ensures full compliance with EPA requirements and provides residents with access to important information about their water service. - **Replacement Plan Development:** Partnering with Christopher B. Burke Engineering, Ltd. (CBBEL), the Village began drafting a comprehensive project plan to try to secure funding through the Public Water Supply Loan Program (PWSLP).
- **Water Filter Pitcher Distribution Program:** To ensure EPA compliance and protect vulnerable households during the transition period, the Village implemented a program to provide affected residents with water filter pitchers.

MRDLG's allow for a margin of safety. **Action Level (AL):** The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow. **Action Level Goal (ALG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. ALG's allow for a margin of safety. **Level 1 Assessment:** A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system. **Level 2 Assessment:** A Level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions. **N/A:** not applicable. **Treatment Technique (TT):** A required process intended to reduce the level of a contaminant in drinking water. **mrem:** millirems per year (a measure of radiation absorbed by the body). **ppb:** micrograms per liter or parts per billion – or one ounce in 7,350,000 gallons of water. **ppm:** milligrams per liter or parts per million – or one ounce in 7,350 gallons of water.

Public Notice

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER – Monitoring Requirements Not Met for the Village of Westchester

The Illinois Environmental Protection Agency (IEPA) requires public water suppliers to notify the community about certain monitoring and reporting violations. The Village of Westchester is required to monitor your drinking water for specific contaminants on a regular basis. The results of regular monitoring are an important indicator of whether or not your drinking water meets health standards.

Our water system violated two drinking water standards over the past year. Even though these were not emergencies, as our customers, you have a right to know what happened and what we did to correct these situations. During the month of December 2024, we did not complete all required monitoring for haloacetic acids (HAA5) and total trihalomethanes (TTHM). **The sample for this testing was collected on December 3, 2024, which was prior to the required sample window of December 5–19, 2024.** As a result, we cannot be sure of the quality of your drinking water during that specific monitoring period. The IEPA issued two Tier 3 violations to the Village of Westchester as a result of this timing error.

What Does This Violation Mean?

A Tier 3 EPA monitoring violation occurs when a water system fails to comply with a monitoring or reporting requirement that does not pose an immediate risk to human health. In this case, the violation was due solely to the sample being collected earlier than allowed by the IEPA—not due to contamination or a failed water quality result.

What Has Been Done?

We have since completed all required monitoring. All subsequent testing has shown that the water continues to meet all IEPA health and safety standards.

What Should You Do?

No immediate action is required. Your water remains safe to drink and use for all household purposes. Please share this information with all the other people who drink this water, especially those who may not have received this notice directly. You can do this by posting this notice in a public place or distributing copies by hand or mail.

Fifth Unregulated Contaminant Monitoring Rule (UCMR 5)

As required by UCMR 5, EPA's latest monitoring cycle, the City of Chicago has completed monitoring for 25 perfluorinated & polyfluorinated alkyl substances, 4 perfluorinated alkyl acids, and lithium in its drinking water for four quarters in 2024. None of the contaminants were detected in our drinking water.

TURBIDITY

Turbidity is a measure of the cloudiness of the water. We monitor it because it is a good indicator of water quality and the effectiveness of our filtration system and disinfectants.

UNREGULATED CONTAMINANTS

A maximum contaminant level (MCL) for this contaminant has not been established by either state or federal regulations, nor has mandatory health effects language. The purpose for monitoring this contaminant is to assist USEPA in determining the occurrence of unregulated contaminants in drinking water, and whether future regulation is warranted.

FLUORIDE

Fluoride is added to the water supply to help promote strong teeth. The Illinois Department of Public Health recommends an optimal fluoride level of 0.7 mg/L with a range of 0.6 mg/L to 0.8 mg/L.

SODIUM

There is no state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials who have concerns about sodium intake due to dietary precautions. If you are on a sodium-restricted diet, you should consult a physician about the level of sodium in the water.

SOURCE WATER ASSESSMENT SUMMARY

Source Water Location

The City of Chicago utilizes Lake Michigan as its source water via two water treatment plants. The Jardine Water Purification Plant serves the northern areas of the City and suburbs, while the Sawyer Water Purification Plant serves the southern areas of the City and suburbs. Lake Michigan is the only Great Lake that is entirely contained within the United States. It borders Illinois, Indiana, Michigan, and Wisconsin, and is the second largest Great lake by volume with 1,180 cubic miles of water and third largest by area.

Source Water Assessment Summary

The Illinois EPA implemented a Source Water Assessment Program (SWAP) to assist with watershed protection of public drinking water supplies. The SWAP inventories potential sources of contamination and determined the susceptibility of the source water to contamination. The Illinois EPA has completed the Source Water Assessment Program for our supply.

Susceptibility to Contamination

The Illinois EPA considers all surface water sources of community water supply to be susceptible to potential pollution problems. The very nature of surface water allows contaminants to migrate into the intake with no protection, only dilution. This is the reason for mandatory treatment of all surface water supplies in Illinois. Chicago's offshore intakes are located at a distance where shoreline impacts are not usually considered a factor on water quality. At certain times of the year, however, the potential for contamination exists due to wet-weather flows and river reversals. In addition, the placement of the crib structures may serve to attract waterfowl, gulls and terns that frequent the Great Lakes area, thereby concentrating fecal deposits at the intake and thus compromising the source water quality. Conversely, the shore intakes are highly susceptible to storm water runoff, marinas and shoreline point sources due to the influx of groundwater to the lake.

2024 VOLUNTARY MONITORING

The City of Chicago has continued monitoring for Cryptosporidium, Giardia and E. coli in its source water as part of its water quality program. No Cryptosporidium or Giardia was detected in source water samples collected in 2024. Treatment processes have been optimized to provide effective barriers for removal of Cryptosporidium oocysts and Giardia cysts in the source water, effectively removing these organisms in the treatment process. By maintaining low turbidity through the removal of particles from the water, the possibility of Cryptosporidium and Giardia organisms getting into the drinking water system is greatly reduced.

In 2024, CDWM has also continued monitoring for hexavalent chromium, also known as chromium-6. USEPA has not yet established a standard for chromium-6, a contaminant of concern which has both natural and industrial sources.
