  - c. Implementation of Public Act 98-760- Illinois Firefighter Hiring Law: (Legislative change of passing score on Firefighter Candidate Written Exams from Median Score to Set Passing Score)

Senate Bill 2826 was signed into law by the governor and is effective as of July 17, 2014. It has become P. A. 98-0760 and eliminates the "median" as the passing point for original entry fire fighter written examinations. The amended statute(s) now permit a fire and police commission, civil service commission, and/or a board of fire commissioners to set a minimum passing point for the written examination. Specifically, the statutes now provide as follows:

"... Passage of the written examination means attaining the minimum score set by the commission. Minimum scores should be set by the commission to demonstrate a candidate's ability to perform the essential functions of the job. The minimum score set by the commission shall be supported by appropriate validation evidence and shall comply with all applicable state and federal laws." (Emphasis supplied).

- e. Fire: Captain's Promotional List (expires May 6, 2017)
- f. Police: Sergeant Promotional List (expires May 9, 2017)
