## MEETING MINUTES FIRE AND POLICE COMMISSION MEETING November 2, 2022

### **CALL TO ORDER:**

The meeting was called to order at 5:45pm followed by the Pledge of Allegiance. Responding present to roll call were Commission Chair McCarthy and Commissioner Pedersen. Commissioner O'Shea arrived at the meeting 10 minutes late. Also present was assistant Mary Detente.

### **EXECUTIVE SESSION:**

A motion was made by Commissioner McCarthy to adjourn to executive session for the purpose of discussing: Appointment, Employment, Compensation, Promotion and Discipline of Village Employees. Motion was seconded by Commissioner Pedersen and the meeting went into executive session at 5:47pm

### **APPROVAL OF MINUTES:**

Commissioner O'Shea made a motion, seconded by Commissioner Pedersen, to approve the Regular Meeting Minutes of October 5, 2022, and the Special Meeting Minutes of October 20, 2022. The motion passed and the minutes were approved.

### **NEW BUSINESS:**

The only item of new business to discuss was Entry level Police Testing. The BFPC is in the process of establishing a new eligibility list for police officer. The application is available from IO Solutions and will be available through November 8<sup>th</sup>. The written test will take place on December 10<sup>th</sup>.

### **OLD BUSINESS:**

The first item of old business was entry-level firefighter testing. Commissioner McCarthy explained that the interview process is now complete. The Commission will score the interviews and post an Initial list as soon as possible.

Commissioner McCarthy then went on to discuss vacancies in the Fire Department. There are still 3 vacancies to fill in the department currently. The Commission has 1 eligible candidate from the current list and is working to establish a new list to fill the remaining vacancies.

The final item to discuss was vacancies in the police department. There are 2 vacancies in the police department to fill. Candidate Adrian Alicea is scheduled to start the academy in January to fill 1 of the vacancies. The Commission is working to establish a new list to fill the remaining vacancy.
