The victim reported an unknown male entered an unlocked pickup truck, rummaged through the vehicle, and took a garage door opener and insurance card. Surveillance video captured the suspect entering the vehicle. Officers located a subject matching the description nearby and took him into custody after he attempted to flee and resist arrest. During the investigation, the suspect admitted entering the unlocked truck but denied taking anything. A 20 year old from Chicago, was charged with Felony Burglary to Auto and Resisting a Peace Officer.
